The Airbag Hazard

The root of the problem lies in the airbags of these vehicles. Over time, a component within the airbag system can deteriorate, potentially leading to explosive fragmentation. Toyota's Stark Warning:

Toyota's statement emphasizes the gravity of the situation: "Owners SHOULD NOT DRIVE these vehicles until the FREE safety recall repair has been conducted."

Understanding the risks of driving these vehicles, Toyota recommends against owners driving to dealerships for repairs. Instead, they offer several alternatives:

- Mobile Repairs: Technicians can conduct repairs at the vehicle's location.

The Takata Airbag Issue

Dual Recall for Corolla and Matrix

The recalled RAV4 models are equipped with Takata driver's airbags, while the Corolla and Matrix have them on the passenger side. Additionally, the Corolla and Matrix are subject to another recall due to airbags potentially deploying without a crash.

Takata's Troubled History

Takata's use of ammonium nitrate as a propellant has been controversial. This compound, intended to inflate airbags during crashes, can become unstable over time, especially in high humidity and temperature conditions. The result can be a violent explosion, causing the airbag's metal canister to rupture and eject shrapnel.

Global Impact

- **Fatalities:** At least 26 deaths in the U.S. and over 30 globally, including cases in Malaysia and Australia.
- Injuries: Approximately 400 reported injuries.
- **Corporate Fallout:** The issue contributed to Takata's bankruptcy.

Previous Recalls and Ongoing Safety Concerns

This recall comes on the heels of another major Toyota recall, involving approximately 1 million U.S. vehicles. The earlier recall addressed issues with front passenger airbags not deploying correctly in crashes.
